

離婚，死別，未婚等により，18歳までの子を監護するひとり親世帯の方への臨時特別給付金について

Information regarding the Temporary Special Benefit Payment for single parent households; for single parents responsible for the care and custody of children up to age 18, as a result of divorce, the death of a spouse, childbirth by a single person, etc.

新型コロナウイルス感染症の影響を受けて，収入が低下した等により生活に困難を抱えるひとり親世帯のかたへ申請により臨時特別給付金が支給されます。

Through an application process, Temporary Special Benefit Payments are provided to single-parent households that have experienced a decrease in income due to the effects of COVID-19.

対象者

離婚，死別，未婚等により父または母が不在の子を監護するひとり親または養育者

Eligible parents or guardians

Single parents or guardians who are responsible for the care and custody of a child, where the mother or father is not living with the family as a result of divorce, death, childbirth by a single person, etc.

対象児童

18歳（年齢到達後の最初の3月31日まで含む。また，障害をお持ちのお子さんで特別児童扶養手当受給対象となっているかたは20歳）までの子

Eligible children

Children up to the age of 18. (The child is eligible up to and including the 31st of March that first occurs after reaching the age of 18. For children with disabilities who

are eligible to receive Special Child Support Allowance, the age is extended to 20.)

申請

①児童扶養手当受給中のかた

基本給付は申請が不要です。令和2年8月3日に振込済みです。

新型コロナウイルス感染症の影響で収入が減少している場合には、申請により追加で給付金が支給されます。児童扶養手当を受給中のかたには、7月21日発送で個別に申請書を送付済みです。

②児童扶養手当を受給していないかた

新型コロナウイルス感染症の影響で収入が一定額未満となっている場合には、申請により給付金が支給されます。

Application

①For those receiving Child Dependent Allowance

The basic benefit payment does not require an application. The payment was completed by direct deposit on August 3, 2020.

If income decreased as a result of the effects of COVID-19, an additional benefit payment will be provided through an application process. Application forms were sent individually on July 21 to those receiving Child Dependent Allowance.

②For those who are not receiving Child Dependent Allowance

If income was below a certain amount as a result of the effects of COVID-19, a benefit payment will be provided through an application process.
